

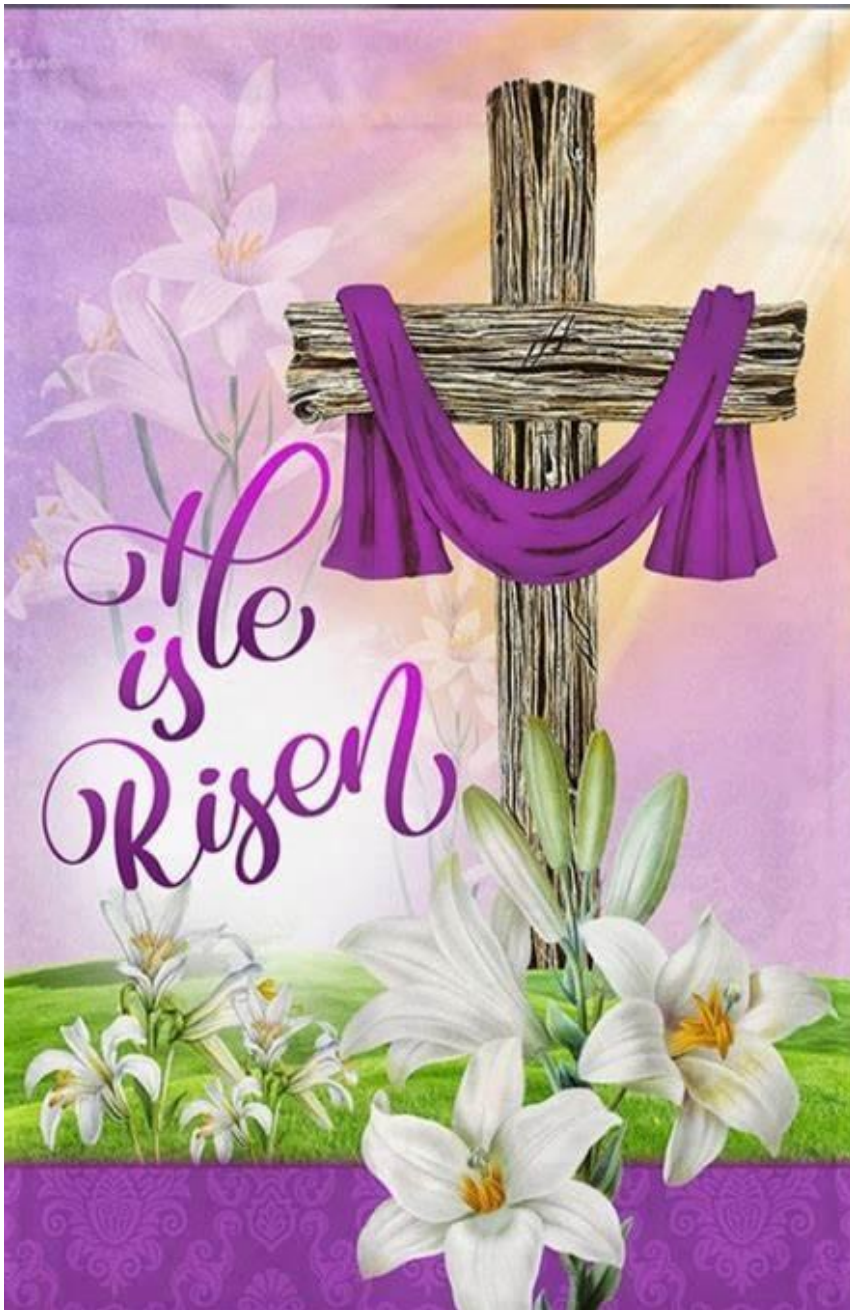


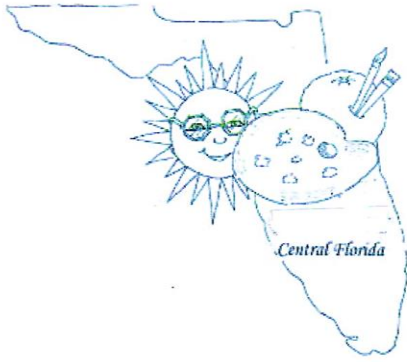

ODA General Meeting Minutes

March 18, 2023

Meeting was called to order at 10:00 AM by Grace Pattison.

Grace began a discussion about the merge of ODA and CRDA. One of the reasons members voted to merge into one club was because of the cost of incorporating the new club as a non-profit organization with the state of Florida, refilling with the IRS, and changing banks. Most clubs that used to be associated with SDP are hiring a lawyer to this. The cost of a lawyer and the paperwork necessary is about \$600.

Bonnie Rand has a copy of the merged by-laws for ODA and CRDA. Vicki Alley had updated CRDA's by-laws to remove mention of SDP. Bonnie used those and the original by-laws of ODA to come up with the new version. Membership has not voted on the new version of the by-laws.

Grace Pattison (CPA) will talk to the person in Maine (Bonnie's painting club) to make sure she has the information to do the paperwork necessary for the new club. Bonnie will give her the revised by-laws and the treasures will give her budget information. She can file the paperwork for about \$145.

New officers have not been elected. We need to make sure that we have officers who support the new club especially since we meet at two locations. There was a discussion about the new name of the club. It was suggested that we use a more neutral name instead of using one of the old names. Grace also asked the treasures to provide her with tax information. The members present voted by a show of hands to continue with the merger. After several suggestion for a name for the new club, Lynn Ingersoll suggested "Decorative Painters of Central Florida" and agreed to by all those attending the meeting.

The next meeting (April 22nd) will be in Lake Wales. The workshop will be a zebra in colored pencil. The pattern is in an e-book from Lydia Steeves called Fur and Feathers – Africa. It is available on her website for \$24.04 (includes 8 designs). If you have questions, please contact Andie Scott or Lynn Ingersoll.

Meeting was adjourned at 10:42 AM.

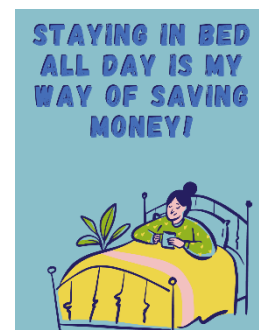

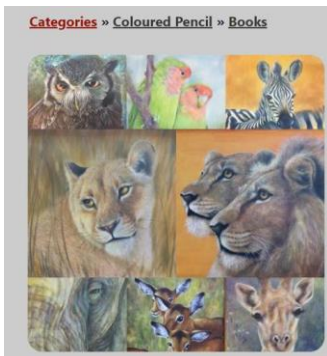

Lydia Steeves' "The Resting Spot" is a colored pencil piece using Pan Pastels on paper (zebras). Several people have already ordered their own e-book and need to bring their own electronic device to view the project in class, and/or print the project and bring with them to class. Lydia prohibits us from reproducing her materials for others.



I have ordered the Pan Pastels, some sponges and a few of the Neo color II white pastel to share in class and will bring odorless thinner. The surface will be your choice of what you want to bring, but it lists Stonehenge Fawn 9 3/4" x 9 3/4" paper and Scharff moon scrubber #0 and #2 brushes. The pencils are the following Prismacolor Premier pencils: Ultramarine PC902, True Blue PC903, Non-Photo Blue PC919, White PC938, Black PC935, Burnt Ochre PC943, Sunburst Yellow PC917.
